- MOP 1 MOP was present during the meeting with the Traffic Management Officer at North Yorkshire Police, a Senior Traffic Management & Road Safety Engineer noted that vehicles were parked on pavements near Bentham Primary School after looking at satellite imagery, if these were parked on the road it may naturally slow traffic down, MOP noted that at the site meeting these cars were still there, a ClIr stated that these residents had been given permission from the PCSO to park there, due to the traffic island and the pavement ending shortly after the parked cars, this information came direct from a resident through social media. MOP asked if this was normal procedure.
- MOP 2 resident of Bentham and a Governor of Settle College request Bentham Town Council support Settle College to reverse the changes to the North Yorkshire Council policy on school transport; to re-instate the catchment and ensure pupils are not sent out of county. Policy changes state free transport from Bentham to Queen Elizabeth School at Kirkby Lonsdale, Bentham children starting no longer qualify for funded transport from NYC to Settle College. In recent years 60% of children from this area have chosen Settle College, after the new policy a survey in local Primary schools showed that 12 out of the 39 potential applicants for new starters for September 2025, loss of pupils results in significant loss of funding, schools are funded per pupil. Families with pupils already attending Settle College may find that siblings will have to attend a different school, disruptive to families, Settle College funded a bus for starters for September 2025. Richmond is significantly affected by the change in policy. Settle College have support from Cllr David Ireton, David Stainton and MP Julian Smith. Changes are being implemented

to save money. Differences of distances between QES and Settle College from Bentham are small, potentially needing another bus for QES for the increase in pupils attending. OFSTED report says that this is a close-knit nurturing school, pupils can achieve and do achieve academically, ethos be the best you can be is understood by all, pupils are welcoming and polite, staff are happy to work at the school with ambitious pupils, all pupils, including vulnerable pupils, have access all opportunities, pupils strive and thrive.

This is a school worth fighting for – to give pupils the opportunity to attend a school like this.

Dear Mayor, Deputy Mayor and Town Councillors

I write to provide a further update from Angus Fire. As with all of our previous communications, this will be based solely on facts that the Town Council and local community can rely on.

Angus continues our approach of 'Containment', 'Characterisation' and 'Corrective Action/Remediation'.

Containment

Our objective remains to ensure that this contamination is contained on site and whilst we await the arrival of the new stormwater treatment plant, we continue to capture and store surface water run-off from impacted areas.

We have recently been informed that the stormwater treatment facility has been delayed in transit (due to sea freight issues) and will now arrive in Bentham at the start of March. We will then need a few weeks for installation and testing before the equipment is fully operational.

We estimate that it will take us approximately eight months to process all of the collected stormwater, on top of any regular rainfall that adds to the already captured volumes.

We are on track with our extensive new tank installation on site, both those that will receive the stormwater pre-treatment, together with the ones that will receive water, post-treatment. This second set of tanks are where it will be held whilst samples are taken and sent away to an independent lab for testing. If testing confirms the water is within the limits agreed with the Environment Agency, it will be released. If for any reason it is not, it will go back through the treatment plant for further processing.

Characterisation

As previously advised, we expect site characterisation activities by independent and industry leading environmental consultants to continue for several years. They will undertake the detailed analysis required to better understand what contamination there is and help us to determine what Corrective action/Remediation is required.

We have been asked a few times about the quality of drinking water, which as people will know, is supplied to the town by Yorkshire Water. As a precautionary measure, we had tap water samples taken from across the Angus site and sent them off for independent laboratory analysis. As expected, all results came back within the Drinking Water Inspectorate's (DWI) quality standards, thus confirming what Yorkshire Water had already publicly advised when approached on the issue.

Corrective Action/Remediation

We will continue to work closely with the regulator, the Environment Agency, and keep them informed on progress made in addition to the monthly updates provided to the Town Council, as we address these very challenging issues over the months and years ahead.

Dear Mr Mayor, Councillors,

In reference to last month's letter AISG is Angus International Safety Group. AISg is the parent company of Angus Fire, it is also the parent company an American and French firefighting foam firm.

I apologise for the use of an abbreviation without explanation.

It was regretful to hear what was said by councillors at last month's Bentham Town Council meeting, regarding the Council being "in total support of Angus's version of events and that it is felt they are handling this.

What the group found more disturbing was Cllr Marshall's and Cllr Burtons out right support for the firm with only Mr Williams side of the story being heard, the Council have had no expert discussions nor have not spoken to any agency with knowledge of these issues before their support was given. Regardless the councils' stakeholders (the residents) do not hold the same confidence that this is the case.

As you may or may not be aware from the Channel 4 news piece in January 2025, the Environment Agency and other government bodies have met about the Angus situation and feel that Angus 'may' have not taken the advice given by their own consultants over the last 12 years (or more). From our groups understanding from investigations of the Environment Agencies Environmental Reports on Angus Fire, Cleaner Bentham is of the opinion that this is more than likely to be what happened.

I've attached the memo to this letter if you have not seen this. (Page 2) and the UKHASs concern that information is coming primarily from Angus Fire (page 10).

A full timeline of breaches by Angus Fire and a breakdown of their reports are available for all to see on the Cleaner Bentham website.

As is a fully transparent timeline of the letters (and eMails) including ones 'not published' by the firm, who are refusing to acknowledge a request for blood testing of volunteer residents. One would ask why is this, and what is there to hide?

Angus Fire has also refused to answer numerous questions posed by Cleaner Bentham's Solicitors Mishcon de Reya on whether health checks on workers past or present have ever been made on workers knowing that they have been working with these dangerous chemicals. We are aware health checks were done in the past to check workers for asbestosis.

A further concern we have is that the council is happy with the proposal from GEOSYNTEC (Angus Fires consultants) to *continue* to release the contaminated water into the Wenning.

In December 2024, the Environment Agency was handed evidence (uncovered by Cleaner Bentham's research) that High Temperature incineration (HTI) was ineffective in destroying PFAS, the letter to them was accompanied by (Scholarly) research done on an American HTI that was burning PFAS at 1600 degrees C.

The EAs current advisable burning temperature is 1100 degrees C, 500 degrees lower than the Americans recommended Incineration process. Angus Fires testing on site was at most, 800 degrees C.

The Environment Agency are now looking into whether HTI is a suitable means of disposal. One would hope this is enough to raise concern within the council and Mr Williams would be more willing to answer the question coming from the representatives of Bentham's Residents.

As a group we remain committed to working with the Town Council so you are able to ask questions to an independent Environmental Consultant who volunteered his services for our community's benefit.

Cleaner Bentham has also spoken with Channel Four, BBC, online, BBC Morning live and more recently BBC World Health online about the situation.

One of Cleaner Bentham's main objectives is to turn the negative press the Town Bentham has received Due to the pollution from what seem to be plainly irresponsible and dangerous actions.

The response from the Environment Agency, by looking into HTI's shows our group is managing this positive press.

We look forward to your written response.
